Eligible Entrants	<p>Australian residents aged 18 years and over and who are:</p> <ul style="list-style-type: none"> Available at half-time (roughly 5:45pm) of the Melbourne City FC v Melbourne Victory match to participate in the "Indomie Kick in the Cup Half Time Challenge 2019" on-field kicking tournament on 21 December 2019 at AAMI Park; Have an Australian Passport valid for international travel for the period 17 January 2020 – 24 January 2020; and Meet any additional eligibility requirements set out in the Conditions of Entry.

The return flight will depart Manchester on Thursday 23 January 2020, arriving into Melbourne on Friday 24 January 2020</p> <ul style="list-style-type: none">• Accommodation in Manchester for five (5) nights <p>The winner and companion must be able to travel on Friday 17 January 2020 returning on Friday 24 January 2020 in order to take the Prize, otherwise the travel prize is forfeited. Any additional expenses or additional charges incurred for ticketing changes are to be borne by the winner. Prize Selection	Method:	<p>Two (2) entrants will be selected, based on their answer to the question “Who would you take with you to Manchester and why?” from all eligible entries received by the Promoter during the Promotional Period for the opportunity to participant</p> <p>The two competitors will have five attempts, one at a time and taking it in turns, to kick a football from the designated spot to the Indomie Cup.</p> <p>FIVE points will be awarded if the football is kicked into the cup and lands in the cup. ONE point will be awarded if the football is kicked and hits the Indomie Cup on the full. ZERO points will be awarded if the football lands inside the Indomie Cup or hits the Indomie Cup after touching the ground.</p> <p>An eligible kick must take place from the designated distance. A kick will only be deemed eligible if taken from the ground with the entrant not using any part of their hands or arms to help kick the football.</p> <p>The competitor with the highest number of points after five kicks each will be deemed the winner and win the Travel Prize.</p> <p>If both competitors are on equal points after five attempts, the competition will move into Sudden Death. Each competitor will continue to take it in turns to kick at the Indomie Cup with one competitor having to hit the Indomie Cup (either on the full or the football into the Indomie Cup) and the other competitor to miss to be deemed the winner and win the Travel Prize.</p> <p>In the event that after five rounds of Sudden Death, a winner has not been determined, the Travel Prize will not be awarded.</p> <p>A maximum of one Travel Prize will be awarded.</p>

CONDITIONS OF ENTRY

- Information on how to enter and Prize(s) form part of the Schedule and these Conditions of Entry. These Conditions of Entry must be read in conjunction with the Schedule for the Promotion. 9. Eligible Entrants can only enter in their own name. The Promoter reserves the right to request the Eligible Entrant produce (within the requested time) appropriate photo identification or other documentation (to the Promoter's satisfaction, at its sole discretion) in order to confirm the Eligible Entrant's identity, age, residential address, eligibility to enter and claim a Prize, and any information submitted by the Eligible Entrant in entering the Promotion, before issuing a Prize (including confirming consent of an Eligible Entrant's parent or legal guardian and the name, age and address of the parent or legal guardian who gave their consent, where an Eligible Entrant is under 18 years of age, if applicable). The Promoter reserves the right to verify the validity of any and all entries and to disqualify any Eligible Entrant for: (a) tampering with the entry process; (b) submitting an entry which is not in accordance with these Conditions of Entry; or (c) engaging in any unlawful or other improper misconduct calculated to jeopardise the fair and proper conduct of the Promotion. The Promoter's legal rights to recover damages or other compensation from such an offender are reserved. A Prize will only be awarded following any winner validation and verification that the Promoter or its agents require in their absolute discretion.
10. If the Promotion is not capable of running as planned and/or a Prize (or element of a Prize) becomes unavailable for any reason beyond the reasonable control of the Promoter, the Promoter reserves the right, in its sole discretion, to cancel, terminate, modify or suspend the Promotion and/or if necessary to provide comparable prize(s) (or prize element) of equal or greater value to the original Prize(s).
11. The Promoter, its franchisees (if applicable) and its associated agencies and companies exclude all liability (including negligence) except for any liability that cannot be excluded by law (including any applicable Consumer Guarantee under the Australian Consumer Law), for any direct or indirect injury, loss and/or damage arising in any way out of the Promotion. This includes, but is not limited to: (i) technical malfunctions, delays or failures, including those resulting from accessing any materials related to this Promotion and any incorrect, inaccurate or incomplete information communicated in the course of, or in connection with, this Promotion as a result of any technical malfunctions, delays or failures; (ii) theft, unauthorised access or third party interference; (iii) lost or damaged entries, Prize claims or Prize(s); and/or (iv) acceptance and/or use of any Prize.
